24th Annual Tribal Legislative Day

Indian Nations and Tribal Legislative Day is held every year to celebrate the rich culture and history of Arizona's Tribes and Nations and also to address issues of mutual interest.

Strengthening Sovereign Responses to Sex Trafficking in Indian Country and Alaska

A conference sponsored by U.S. Department of Justice, Office on Violence Against Women, the Minnesota Indian Women's Sexual Assault Coalition, Mending the Sacred Hoop, Men as Peacemakers, and the Tribal Law and Policy Institute, the conference provided an opportunity to strengthen alliances by bringing together Tribal Leadership, Federal partners, experts in the field, and tribal communities to better address the safety of our children, women, and men.

Workshops included assisting programs and agencies with information regarding sex trafficking in Indian Country, implementations, and highlighting key issues to improve the responses to Americana Indian/Alaska Native Survivors of sex trafficking.

Operation Lady Justice Task Force on Missing and Murdered Native Americans

The important work of the Presidential Task Force on Missing and Murdered American Indians and Alaska Natives continues. The task force, designated Operation Lady Justice, aims to review Indian Country cold cases, strengthen law enforcement protocols, and work with tribes to improve investigations, information sharing and a more seamless response to missing persons investigations.

In early March, the task force announced a series of field consultations and listening sessions to occur across the United States. In light of guidance to prevent the further spread of COVID-19, some sessions will have to be rescheduled. In spite of this disruption, the task force is committed to meaningful consultation and dialogue with American Indian and Alaska Native people and leaders as part of this process.



National Day of Awareness of Missing and Murdered of Indigenous Women and Girls (MMIWG)

To honor Missing and Murdered Indigenous Women and to bring awareness to the issue, on May 5, 2020, SWIWC participated in the National Indigenous Women's Resource Center's "Honoring Missing and Murdered Indigenous Women to Guide Our Advocacy for Change" Webinar.
