# SWIWC HIGHLIGHTS

## SWIWC's Holds **First** Virtual 40-Hour Native Victim Advocacy Training

For the month of April, every Tuesday and Thursday, for four weeks, SWIWC successfully completed its first 40-hour Native Victim Advocacy training for new and experienced advocates.

This was a long-time-in-coming work of the heart and could not have been achieved without the assistance of incredible experts in the field that served as our faculty as well as from the generosity of volunteers, and support from our staff and board.

Input from our Advocate Talking Sessions helped determine topic areas including, victim-centered advocacy, advocacy and the criminal justice system, mobile advocacy, children and domestic violence, youth and technology suicide prevention, stalking, and non-fatal strangulation. Also, included was information focused on the LGBTQ+ and Two Spirit community, sexual violence,

working with law enforcement and prosecuting domestic and sexual violence cases, and coordinated community response. The training ended with the importance of self-care and healing as a reminder of what is needed to continue this work in a good way.

Although we had hoped this 40 training would be in person, due to the COVID-19 pandemic still amongst us, the training was provided via ZOOM. This training was rewarding for SWIWC and we are excited it will be an annual event.

We wholeheartedly thank all the participants, the presenters, SWIWC's Native LGBTQ2S Advisory Council, volunteers, our board and staff for a great and successful training!

# SWIWC HIGHLIGHTS

## 7th Gathering for Healthy Relations Statewide Hybrid Conference #G4HR2022

SWIWC and the Pascua Yaqui Tribe co-hosted this years, **7th Gathering for Healthy Relations Hybrid Conference** (#G4HR2022) at the Casino Del Sol Resort in Tucson, Arizona on May 3-5, 2022. The conference took place on the land of the Pascua Yaqui Tribe.

The primary goal for #G4HR2022 was to bring together service providers to network, share information and resources, and to create opportunity to increase skills and knowledge around safety, healing, and justice for survivors of intimate partner and sexual violence.

The conference began with April Ignacio from Indivisible Tohono and Alfred Urbina, Pascua Yaqui's Attorney General speaking about the crisis of Missing and Murdered Indigenous Women, Girls and Relatives (MMIWG/R) as it was important to acknowledge that the conference was being held during the week of action leading up to May 5th, the National Day of Awareness and Action for MMIWGR.

The week of the conference included other awesome plenary speakers including Dawn Stover, Executive Director, Alliance of Tribal Coalitions to End Violence, who provided important information on the 2022 Reauthorization of Violence Against Women's Act; and, the Honorable Kendrick Wilson, Oscar Flores, Malena Acosta, Coleen Thoene from Pascua Yaqui, which was one of the three tribes initially selected by the USDOJ to implement Special Domestic Violence Criminal Jurisdiction pursuant to VAWA 2013, which they began exercising in 2014.

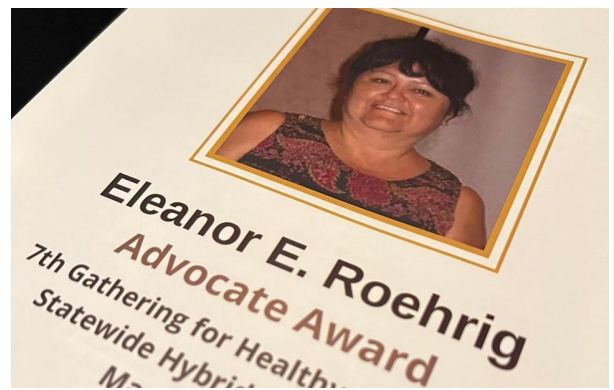
## 7th Gathering for Healthy Relations Statewide Hybrid Conference #G4HR2022 - Continued

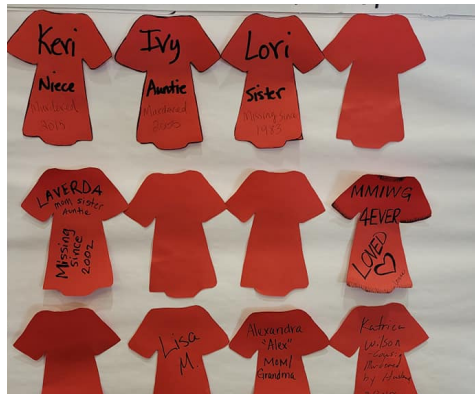

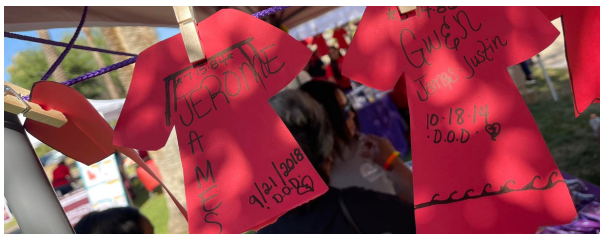

The Commission will focus on addressing violent crime within Indian lands and against American Indians and Alaska Natives.

Deb Haaland (Laguna Pueblo), became the Secretary of U.S. Department of Interior in 2021. Haaland is the first Native American to serve in this role. Haaland now leads the Not Invisible Act Commission which she sponsored when she served in Congress.

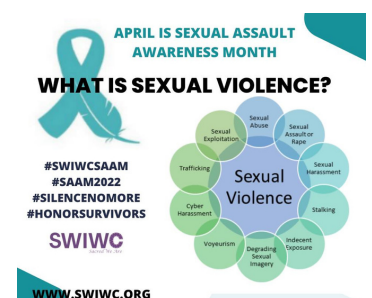

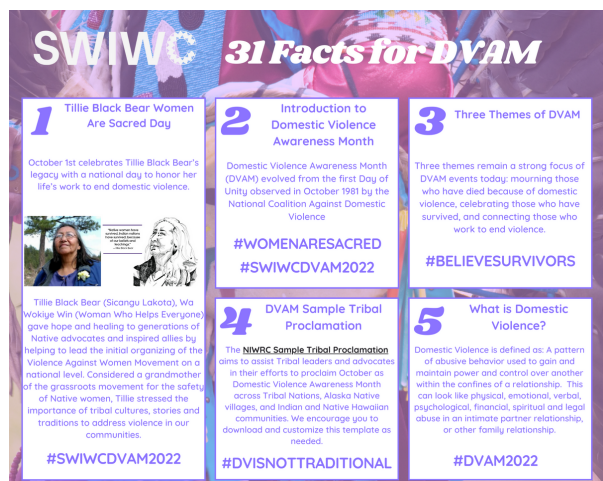

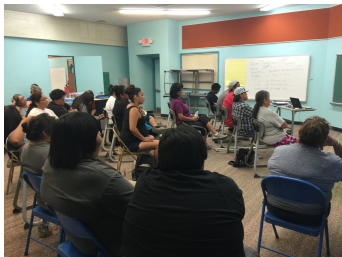

## Requesting SWIWC Training and Technical Assistance



SWIWC provides training and technical assistance. Training services include a wide range of topics relating to domestic violence, sexual assault, stalking, sex trafficking, teen relationship violence (dating violence) and the missing and murdering of our Indigenous relatives. The length of training varies from a minimum of 4 hours to 1-3 days depending on the level of need and are provided with the assistance of partners and/or subject matter experts who serve as SWIWC faculty.

Trainings are interactive, culturally competent, and based on best practices available. They are offered statewide, regionally, on-site, or virtually and may involve a fee which includes the expenses related to the time and travel of staff and faculty in developing and providing the training.

Technical assistance (TA) services are tailored specifically to meet the needs of those requesting the service. TA sessions are held onsite or virtually from 1-2.5 days and are designed to be hands-on, practical, and aimed at increasing the capacity to address and respond to domestic violence, sexual assault, stalking, sex trafficking and teen relationship violence (dating violence). TA sessions are provided with the assistance of partners and/or experts who serve as faculty and may involve a fee for the time and travel expenses of staff and faculty to develop and conduct the TA session.

### Invitation to the Government-to-Government Consultations OVW Tribal Jurisdiction Reimbursement Program

VAWA 2022 also authorized a new program to reimburse Tribal governments for expenses incurred in exercising special Tribal criminal jurisdiction. Eligible expenses for reimbursement under the statute include the following:

- investigating, making arrests relating to, making apprehensions for, or prosecuting covered crimes (including costs involving the purchasing, collecting, and processing of sexual assault forensic materials);
- detaining, providing supervision of, or providing services for persons charged with covered crimes (including costs associated with providing health care);
- providing indigent defense services for 1 or more persons charged with 1 or more covered crimes; and
- incarcerating, supervising, or providing treatment, rehabilitation, or reentry services for 1 or more persons charged with 1 or more covered crimes.

## The 17th Annual Government-to-Government Violence Against Women Tribal Consultation

The Office on Violence Against Women is a grant-making agency in the U.S. Department of Justice. Under §903 of Title IX of the United States Department of Justice Reauthorization and Violence Against Women Act of 2005 (VAWA 2005), OVW is responsible for conducting annual government-to-government consultations with the leaders of all Federally recognized Indian tribal governments on behalf of the United States Attorney General.

- The purpose of each consultation is to solicit recommendations from tribal government leaders on the following topics:
- (1) Administering tribal funds and programs;
- (2) Enhancing the safety of Indian women from domestic violence, dating violence, sexual assault, homicide, stalking, and sex trafficking;
- (3) Strengthening the federal response to such crimes; and,
- (4) Improving access to local, regional, state, and federal crime information databases and criminal justice information systems.

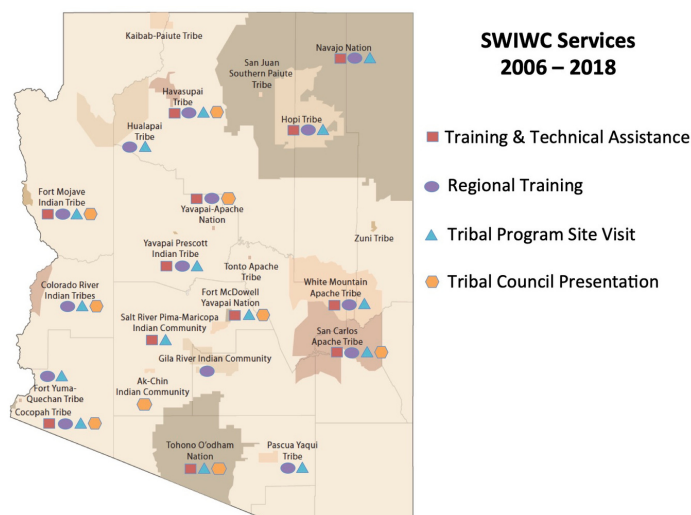
# NIWRC WEBINAR | Tribal Consultation on Violence Against Women Act (VAWA) 2013, Section 903

#### FY 2022 Tribal Access Program

**Closing Date: August 31, 2022**

The Tribal Access Program (TAP) helps provide Tribes with access to national crime information systems for both criminal and non-criminal purposes. OVC is one of the U.S. Department of Justice Program Offices that funds TAP. Tribes may apply for TAP funding for one of the following primary purposes—

- law enforcement;
- sex offender registries authorized by the Adam Walsh Child Protection and Safety Act;
- non-criminal or criminal court issuance of protection orders, or entry of misdemeanor convictions for domestic violence;
- foster care placement; or
- child abuse/neglect investigations.

### Reminders on Submitting Federal Financial Reports and Performance Reports in JustGrants

For many award recipients, one or more Federal Financial Reports (FFRs) or performance reports will be due at the end of July 2022. Here are a few tips and reminders about due dates and what to expect when submitting FFRs or performance reports.

### Federal Financial Reports (FFRs)

- For recipients with active awards, the next quarterly FFR covers the period April – June 2022 and is due on or before July 30, 2022. FFRs not submitted by this due date will result in suspended access to funds.
- For recipients with awards that are past their project period end date and the final reports have not yet been submitted, the final FFR is due on or before 120 days after the project period end date. Example: For awards that ended on March 31, 2022, the final FFR (and other closeout actions) are due on or before July 29, 2022.
- The only role within JustGrants that can submit an FFR is the Financial Manager. Individuals with that role in JustGrants should review the Submitting Financial Job Aid Reference Guide for guidance on how to complete and submit FFRs in JustGrants.

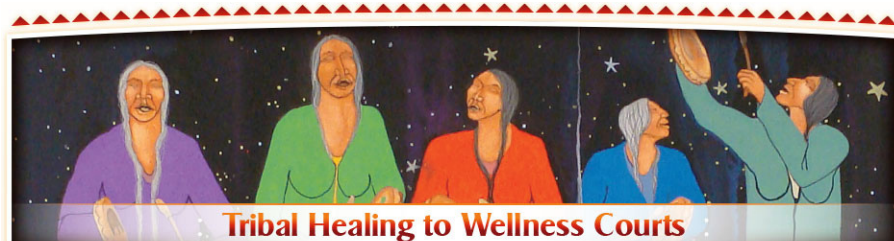

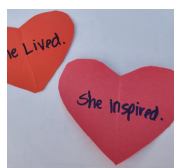
